## [No. 14.] A Resolution to Establish certain Post-Routes.

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That the Postmaster-General shall be, and he is hereby authorized in his discretion, to contract for on which the carrying the mail on all the plank roads which have been or shall be General shall constructed in the United States, and in all cases when in his opinion cause the mail the public interest and convenience require it; and that for the time to be carried, to be post-roads. during which mails may be carried on such plank roads, or any part thereof, the same shall be and they are hereby declared to be post-roads of the United States.

SEC. 2. And be it further resolved, That the road from Vallona Springs Post-row New York. in Broome County, New York, by the way of Nineveh, and Coventry, to Oxford, be, and the same is hereby declared a post-road. And the Postmaster-General is authorized to pay a reasonable compensation for carrying the mail on said route by discretion of the Department, previous to this time. And that the road from Oxford aforesaid, by the way of Coventryville, to South Bainbridge be, and the same is hereby declared a post-road.
