CHAP. LXIV. - An Act to re-define a Portion of the Boundary Line between the State of April 28, 1870. Nebraska and the Territory of Dakota.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That so soon as the State of Nebraska, through her legislature, has given her consent thereto, the and Dakota. centre of the main channel of the Missouri river shall be the boundary line between the State of Nebraska and the Territory of Dakota, between the following points, to wit: Commencing at a point in the centre of said main channel, north of the west line of section twentyfour in township twenty-nine north, of range eight east of the sixth principal meridian, and running along the same to a point west of the most northerly portion of fractional section seventeen, of township twenty-nine north, of range nine east of said meridian, in the State of Nebraska, as meandered and shown by the plats and surveys of said sections originally made and now on file in the general land office.

SEC. 2. And be it further enacted, That the respective jurisdictions of said State and Territory (and of the United States) shall extend to and over all of the territory, within their limits, according to the line herein designated, to all intents and purposes as fully and completely as if no change had taken place in the channel of said Missouri river. And the Secretary of the Interior is hereby authorized and required to cause to be made all necessary surveys and meanderings, and to order the trans- transfer of plats, fer of all plats, papers, and documents which may be necessary in the papers, &c. premises.
