*Be it resolved by the Senate and House of Representatives of the United States of America in Congress assembled,* That the Secretary of War be, and he is hereby, directed to examine and pay the claim of Robert T. Kirkpatrick, of Nashville, Tennessee, for materials taken and used, by military order, in building a fort for the defence of said city: *Provided*, That said amount so allowed shall not exceed the sum of twenty thousand five hundred and twenty-three dollars; *And provided further*, That this shall be final.

Feb. 16, 1871. [No. 35.] *Joint Resolution for the Relief of Captain William O. Sides.*

*Be it resolved by the Senate and House of Representatives of the United States of America in Congress assembled,* That the sum of one hundred and forty dollars be paid, out of any money in the treasury not otherwise appropriated, to Captain William O. Sides, as a captain in command of a detachment of the veteran reserve corps, stationed at Hampton hospital in the State of Virginia, and in charge of stores at that place in the months of July and August, eighteen hundred and sixty-four, after his resignation had been accepted and previous to his being relieved from duty and from the charge of the property which had been committed to his care.
