SEC. 520. There shall be at the seat of Government a Department of Agriculture, the general design and duties of which shall be to acquire and to diffuse among the people of the United States useful information 15 May, 1862, c. on subjects connected with agriculture, in the most general and com-72, s.2, v.12, p. 387. prehensive sense of that word, and to procure, propagate, and distribute prehensive sense of that word, and to procure, propagate, and distribute among the people new and valuable seeds and plants.

time provide, with salaries corresponding to the salaries of similar officers in other Departments of the Government; and he shall, as Congress may from time to time provide, employ other persons, for such time as their services may be needed, including chemists, botanists, entomologists, and other persons skilled in the natural sciences pertain-

ing to agriculture.

SEC. 524. The Commissioner, and the chief clerk, before entering upon their duties, shall severally give bonds to the Treasurer of the United missioner and chief States, the former in the sum of ten thousand dollars, and the latter in ful account to the Treasurer quarter-yearly of all moneys which shall be 72, s. 4, v. 12, p. 388. by them received by virtue of their office with cureties to be 72, s. 4, v. 12, p. 388. by the Solicitor of the Treasury. Such bonds shall be filed in the office of the First Comptroller of the Treasury, to be by him put in suit upon any breach of the conditions thereof.

SEC. 525. The Commissioner of Agriculture shall have charge, in the building and premises appropriated to the Department, of the library, furniture, fixtures, records, and other property appertaining to it, or 72, 8.3, v. 12, p. 387.

SEC. 526. The Commissioner of Agriculture shall procure and preserve all information concerning agriculture which he can obtain by means of books and correspondence, and by practical and scientific experiments, 15 May, 1862, c. accurate records of which experiments shall be kept in his Office, by the 72, s. 3, v. 12, p. 387. collection of statistics, and by any other appropriate means within his power; he shall collect new and valuable seeds and plants; shall test, by cultivation, the value of such of them as may require such tests; shall propagate such as may be worthy of propagation; and shall distribute them among agriculturists.

Sec. 527. Sec. 528. The Commissioner of Agriculture shall annually make a general report in writing of his acts to the President and to Congress, in which he may recommend the publication of papers forming parts of or accompanying his report, which shall also contain an account of all moneys received and expended by him. He shall also make special reports on particular subjects whenever required to do so by the President or either House of Congress, or when he shall think the subject in his charge requires it.

SEC. 529. The Commissioner of Agriculture shall, on or before the fifteenth day of December in each year, make a report in detail to Con-expenditures. gress of all moneys expended by him or under his direction.
