Congress, said reporters to be paid monthly at the rate fixed by law. SEC. 2. That there is hereby appropriated, out of any money in

the Treasury not otherwise appropriated, the sum of one thousand six hundred and thirty-six dollars and twelve cents to pay D. F. Murphy, official reporter of the Senate, for reporting the proceedings and debates of the Senate at the special session of March, eighteen hundred and seventy-three, according to the arrangement made with him by the session of March, Committee on Printing of the Senate, which was reported by said Committee to the Senate on the twenty-first day of March, eighteen hundred and seventy-three.

SEC. 3. That there is hereby appropriated for reporting the proceedings and debates of the Senate for the Congressional year ending March four, eighteen hundred and seventy-four, the sum of six thou-ending March 4, sand dollars, or so much thereof as may be necessary, which sum shall be added to the contingent fund of the Senate and be disbursed by the Secretary of the Senate, agreeably to the terms of the resolution aforesaid: Provided, That from and after the passage of this act a sum not exceeding forty two thousand dollars shall be paid for reporting the proceedings of each House of Congress for any one Congress, under the direction of the respective Houses; and all laws inconsistent herewith are hereby repealed.
