<i>Italy.</i> Declaration between the United States of America and the Kingdom of Italy, for the reciprocal protection of marks of manufacture and trade. Concluded June 1, 1882; ratification advised by the Senate February 25, 1884; proclaimed March 19, 1884.....	726
<i>France.</i> Convention between the United States of America and the French Republic for the further extension of the term of the Claims Commission established under the Convention of January 15, 1880. Concluded February 8, 1883; ratification advised by the Senate, with an amendment, February 21, 1883; ratified by the President of the United States April 3, 1883; ratified by the President of the French Republic June —, 1883; ratifications exchanged at Washington June 25, 1883; proclaimed June 25, 1883.....	728
<i>Spain.</i> Protocol of an agreement concluded between the acting Secretary of State and the Spanish minister in reference to the termination of the American and Spanish Claims Commission, signed at Washington June 2, 1883.....	732
<i>Mexico.</i> Memorandum of an agreement between P. H. Morgan, Envoy Extraordinary and Minister Plenipotentiary of the United States, and José Fernandez, Official Mayor of the Department for Foreign Affairs of Mexico, for the prolongation of agreement signed at Washington July 29, 1882. Signed and exchanged at the city of Mexico June 29, 1883.....	734
<i>Hawaii.</i> Convention between the Post-Office Department of the Kingdom of Hawaii and the Post-Office Department of the United States of America, concerning the exchange of money-orders.....	736
<i>Argentine Republic.</i> Agreement between the United States and the Argentine Republic, for increasing the limits of weight and the dimensions of packets of patterns of merchandise exchanged through the post between the two countries.....	748
<i>Spain.</i> Agreement between the Envoy Extraordinary and Minister Plenipotentiary of the United States at Madrid and the Minister of State of Spain, for the reciprocal abolition of certain discriminating duties in the ports of the United States and in Cuba and Porto Rico. Executed and signed at Madrid February 13, 1884.....	750
<i>Queensland.</i> Convention between the Post-Office Department of the United States of America and the Post and Telegraph Department of the Colony of Queensland, Australia, concerning the exchange of money-orders.....	754
<i>Belgium.</i> Convention between the United States of America and Belgium concerning trade-marks. Concluded at Washington April 7, 1884; ratification advised by the Senate June 12, 1884; ratified by the President July 7, 1884; ratified by the King of the Belgians June 6, 1884; ratifications exchanged July 7, 1884; proclaimed July 9, 1884.....	766
<i>Cape of Good Hope.</i> Convention between the governor of the colony of the Cape of Good Hope and the President of the United States of America concerning the exchange of money-orders.....	768
<i>Congo.</i> Declaration by the International Association of the Congo.....	781
<i>Siam.</i> Agreement between the United States of America and Siam for the regulation of the liquor traffic in S'am. Concluded at Washington May 14, 1884; ratification advised by the Senate June 28, 1884; ratified by the President June 30, 1884; ratified by the Envoy Extraordinary and Minister Plenipotentiary of the King of Siam at Washington June 30, 1884; ratifications exchanged at Washington June 30, 1884; proclaimed July 5, 1884.....	782

<i>Mexico.</i> Protocol of an agreement between the United States and Mexico. Renewing stipulation in former agreements as to pursuit of hostile Indians across boundary. Signed and exchanged at the city of Mexico, October, 31, 1884 .....	806
<i>Luxemburg.</i> Treaty between the United States of America and the Grand Duchy of Luxemburg, concerning extradition of criminals. Concluded October 29, 1883; ratification advised by the Senate July 4, 1884; ratified by the President July 5, 1884; ratified by the King of the Netherlands February 25, 1884; ratifications exchanged at Berlin July 14, 1884; proclaimed August 12, 1884 .....	808
<i>Sweden.</i> Convention for an exchange of money-orders between the Kingdom of Sweden and the Republic of the United States of America. Signed at Stockholm December 27, 1884, and at Washington February 17, 1885 .....	815
