CHAP, 172.—An act for the relief of James R. Marrs.

Payment to.

Be it enacted by the Senate and House of Representatives of the United James R. Marrs. States of America in Congress assembled, That the Secretary of the Treasury be, and he is hereby, authorized and directed to pay out of any money in the Treasury not otherwise appropriated, to James R. Marrs, of Boyle County, Kentucky, the sum of one hundred and twenty-six dollars, to reimburse him for money paid by him to the Post-Office Department of the United States because of money unlawfully taken from the postoffice at Danville, Kentucky, of which James R. Marrs is postmaster, and for the taking of which he was in no respect blamable or responsible.

CHAP. 173.—An act granting a pension to Minerva Abbey.

Abbey, deceased, late of Company I, Fifteenth Kansas Cavalry, at the rate of twelve dollars per month.

CHAP. 174.—An act granting a pension to Catharine Waters.

Be it enacted by the Senate and House of Representatives of the United Wa. States of America in Congress assembled, That the Secretary of the Interior be, and he is hereby, directed to place on the pension roll, subject to the provisions and limitations of the pension laws of the United States, the name of Catharine Waters, mother of Thomas Waters, deceased, late steward of the steamer Benefit, at the rate of twelve dollars per month.

CHAP. 175.—An act to restore the name of Lifurs Roberson to the pension-roll.

States of America in Congress assembled, That the Secretary of the Interior Pension restored be, and he is hereby, directed to restore the name of Lifurs Roberson, late of Company K, Fifth Tennessee Volunteers, in the Mexican war, to the pension-roll.
