

PRIVATE ACTS OF THE FIFTY-THIRD CONGRESS

OF THE

UNITED STATES,

Passed at the third session, which was begun and held at the city of Washington, in the District of Columbia, on Monday, the third day of December, 1894, and was adjourned without day on Saturday, the second day of March, 1895.

CHAP. 2.—An Act Granting a pension to Mary Martin.

December 10, 1894.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Interior be, and he is hereby, authorized and directed to place on the pension roll, subject to the provisions and limitations of the Act of June twenty-seventh, eighteen hundred and ninety, the name of Mary Martin, widow of William Martin, late of Company I, Fourth Regiment of Rhode Island Volunteers: Provided, That in the event the soldier returns this pension shall cease.

CHAP. 4.—An Act To authorize the Secretary of the Interior to issue a duplicate of a certain land warrant to Emma A. Ripley.

December 13, 1894.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Interior be, and he is hereby, authorized to issue to Emma A. Ripley duplicate of one Porterfield land warrant issued in pursuance of the Act of Congress approved April eleventh, eighteen hundred and sixty, numbered sixty, for forty acres, upon satisfactory proof of ownership and loss of same, and the execution of a bond, with good and sufficient sureties, in double the market value of the warrant so to be issued, to be approved by the Secretary of the Interior, conditioned to indemnify the United States against the presentation by an innocent holder of the alleged lost warrant; and that said duplicate shall have all the legal force and effect as had the original.

CHAP. 5.—An Act For the relief of B. F. Berry.

December 13, 1894.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Interior be directed to issue to B. F. Berry, of Simpson County, Mississippi,

a patent to the east half of the northwest quarter of section thirty-six, township two north, range two east, Choctaw meridian, situated in said Simpson County, Mississippi, conveying to said B. F. Berry the title of the United States to said land upon his payment or tender to Lloyd M. Kelley, of said county, of the sum of money paid by said Kelley into the land office at Jackson, Mississippi, for said land, on the twenty-third day of April, eighteen hundred and ninety-four.

CHAP. 13.—An Act For the relief of the legal representatives of James C. Booth.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Treasury be, and he is hereby, authorized and required to pay to the legal representatives of James C. Booth, deceased, late melter and refiner of the Mint of the United States at Philadelphia, out of any money in the Treasury not otherwise appropriated, the sum of one thousand eight hundred and forty-one dollars and eighty-seven cents, in full for the cost value of one thousand nine hundred and eighty ounces and twelve one-hundredths of an ounce of silver bullion, of standard fineness, deposited by him with the Superintendent of the Mint at Philadelphia to make good a deficiency of that amount of bullion in the accounts of the Mint for the fiscal year eighteen hundred and eighty-five, the same being the number of ounces of standard silver bullion contained in three bars missing from said Mint, supposed to have been stolen while in the charge of the melter and refiner, but for which safe storage could not be provided for want of vault capacity in the Mint.

CHAP. 16.—An Act To pension Mrs. Ann Bradford, mother of William K. Bradford.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Interior be, and he is hereby, authorized and directed to place on the pension rolls the name of Ann Bradford, mother of William K. Bradford, late of Company B, Seventy-sixth Missouri Enrolled Militia Volunteers, and to pay her a pension at the rate of twelve dollars per month.

CHAP. 17.—An Act For the relief of Dollie E. Vedder.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Interior be, and he is hereby, authorized and directed to place the name of Dollie E. Vedder, widow of the late Captain Simon C. Vedder, of the Nineteenth Regiment, United States Army, on the pension roll, at the rate of twenty dollars per month, in lieu of the amount she now receives.

CHAP. 18.—An Act To correct the military record of Alexander P. Magaan, of Battery H, Fourth United States Artillery.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of War be, and he is hereby, authorized and directed to cause the military record of Alexander P. Magaan, who enlisted as a private in Battery H, Fourth United States Artillery, on the eighth day of July, eighteen hundred and forty-six, and stands charged with having deserted on the eighth day of September, eighteen hundred and forty-eight, to be corrected by removing said charge of desertion and granting an honorable discharge to said soldier, it appearing that he did not desert, but was absent with leave, sick, and was prevented from returning on account of sickness: *Provided,* That no pay, bounty, or emoluments shall become due by virtue of the passage of this Act.

CHAP. 22.—An Act Granting a pension to Mary Palmer Banks, widow of Major-General Nathaniel P. Banks.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Interior be, and he is hereby, authorized and directed to place on the pension roll the name of Mary Palmer Banks, widow of Nathaniel P. Banks, late major-general of the Army of the United States, and pay her at the rate of one hundred dollars a month.

CHAP. 30.—An Act For the relief of Zimri Elliott, of Wilsey, Kansas.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Treasury be, and he is hereby, authorized and directed to pay the sum of one hundred and thirty dollars, out of any moneys not otherwise appropriated, to the duly authorized administrator of Jacob Grosclose, deceased, late of Company K, Fifteenth Iowa Volunteer Infantry, who was allowed a pension on the nineteenth day of January, eighteen hundred and ninety-four, by certificate numbered eight hundred and sixty-four thousand three hundred and seventy-seven; said one hundred and thirty dollars being the amount of pension money due the said Jacob Grosclose at the time of his death.

H. Cook, late a private in Company G, Fifth New York Duryea Zouaves, and to substitute in lieu thereof "absent without leave from August twenty-fifth, eighteen hundred and sixty-two,

CHAP. 32.—An Act For the relief of I. H. Hathaway and Company.

Preamble.

Whereas it appears that Thomas H. Handbury, major, Corps of Engineers, United States Army, did, on the fourteenth day of June, eighteen hundred and ninety-four, issue a check, numbered two hundred and sixty-nine thousand seven hundred and ninety-eight, for ten thousand one hundred and fifteen dollars and thirty-four cents, on the assistant treasurer of the United States at New York in favor of I. H. Hathaway and Company, in payment of contract work done at mouth of Saint Johns River, Florida, which check is alleged to have been lost in transmission through the United States mails between Saint Augustine, Florida, and Philadelphia, Peunsylvania; and

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the said Thomas H. CHAP. 35.—An Act For the relief of Oliver P. Coshow and others.

Preamble.

Whereas a large portion of the southwest quarter of the northeast quarter, the southeast quarter of the northwest quarter, and lots two, three, four, five, six, and seven, section thirty-one, township thirteen south, range two west, Willamette meridian, in Linn County, State of Oregon, is now occupied by the town of North Brownsville, the property owners whereof claim title through certain persons who purchased the said land in good faith, either from the county school superintendent of Linn County, Oregon, or from the Oregon and California Railroad Company, and that the remainder of said described lands is claimed by Oliver P. Coshow; and

Whereas neither the said school superintendent nor the said railroad company ever had title to the land aforesaid, but that all of the same is now and always has been vested in the United States: Therefore,

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That Oliver P. Coshow, his heirs or legal representatives, is hereby authorized, on the payment of two dollars and fifty cents per acre, within six months after the date of the approval of this Act, to make cash entry of the southwest quarter of the northeast quarter and the southeast quarter of the northwest quarter, and lots two, three, four, five, six, and seven of section thirty-one, in township thirteen south, of range two west, of the Willamette meridian, situated in Linn County, Oregon, at the United

States land office at Oregon City, in said State, upon first giving thirty days' notice of his intention to make such entry by posting at least twenty notices in at least twenty public places in the town of North Brownsville, in said State, such notices to contain a copy of this Act and a statement of the time when such entry will be made: *Provided*, That upon making entry the said Oliver P. Coshow, his heirs or legal representatives, shall deliver to each person claiming to own property in said town, the record title to which property shall have been derived from or through any person claiming under the attempted conveyances by the school superintendent or the Oregon and California Railroad Company, a deed, duly executed, conveying to such person the parcel of land held by him as aforesaid. The entry, when made, shall be transmitted to the Commissioner of the General Land Office, and if he is satisfied that it is in conformity with this Act, and that deeds have been tendered by the entrymen to the various property holders as herein provided, patent shall issue to the said Oliver P. Coshow, or his heirs and legal representatives; but if it shall appear that the entry is not in conformity with this Act, or that due notice has not been given to all interested parties as herein provided, then he may order new notice to be given to the end that all parties in interest may have a full and fair opportunity to present their claims, and upon such new notice the proceedings shall be conducted as though it were a new entry: *Provided, further*, That this Act shall not in any manner interfere with any valid adverse claim or right to said land or any portion thereof.

CHAP. 48.—An Act For the relief of the widow and legal representatives of the late Orsemus B. Boyd, captain in Eighth United States Cavalry.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the accounting officers of the Treasury are hereby directed, on application being made by the widow and legal representatives of the late Orsemus B. Boyd, a private and lieutenant of volunteers, and captain in the Eighth United States Cavalry, for commutation of rations and pay which accrued while said deceased soldier was in the volunteer and regular armies of the United States; to readjust and allow the sum thereon in accordance with the principle of the decision of the Supreme Court of the United States in the Watson case, and to pay whatever shall be found to be due thereunder out of any money in the Treasury not otherwise appropriated.

CHAP. 49.—An Act For the relief of Mrs Victor Thunot.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Treasury be, and he is hereby, authorized and directed to pay Mrs. Victor Thunot the sum of one thousand six hundred dollars, principal money for the redemption of three five-twenty coupon bonds of the United States; one for one hundred dollars, one for five hundred dollars, and one for one thousand dollars, together with coupons attached; for interest due on the one hundred dollar bond from November first, eighteen hundred and seventy-three, to July twentieth, eighteen hundred and seventy-five; on the five hundred dollar bond from November first, eighteen hundred and seventy-three, to the first day of May, eighteen hundred and seventy-five; on the one thousand dollar bond from November first, eighteen hundred and seventy-three, to January first, eighteen hundred and seventy-five; in payment of bonds numbered forty two thousand four hundred and ten, for one hundred dollars; numbered seven thousand eight hundred and eighty-seven for five hundred dollars; numbered ten thousand three hundred and sixty-seven for one thousand dollars; which said bonds are lost or destroyed, and were, respectively, called in at the times herein stated, upon the filing of an indemnifying bond, to be approved of by the Secretary of the Treasury, as prescribed by section thirty-seven hundred and three, United States Revised Statutes, and the regulations of the Department.

CHAP. 51.—An Act Authorizing the sale of title of United States to a tract of land in Montgomery County, in the State of Maryland, to William H. and George Bobinger.

January 26, 1895.

Whereas William H. Bobinger and George Bobinger, of Montgomery County, Maryland, have been in the peaceable and uninterrupted possession of the tract of land in said county and State, hereinafter described by metes and bounds, for a period of fifteen years, under a claim of title and a bona fide belief that the same was indefeasible and in them, and under that belief have made valuable improvements thereon; and

Whereas under recent surveys ordered by the chief engineer of Washington Aqueduct it has been discovered that title thereto is in the United States: Now, therefore,

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of War be, and he is hereby, authorized and required to sell, grant, and convey unto William H. Bobinger and George Bobinger, of Montgomery County, in the State of Maryland, all the right, title, and interest of the United States in and unto all that tract of land in said county and State hereinafter described, at a price to be determined by the Secretary of War upon a consideration of all the circumstances of the case, which price shall be exclusive of the value of the improvements on said land: *Provided,* That the Secretary of War shall be of the opinion that the said sale will in no wise be detrimental to the Washington Aqueduct: *Provided,* That the encroachment thereon was not fraudulent and that the said Bobingers are the bona fide proprietors of the said adjacent land on which said hotel is built:

Mullan to accompany General Baquedano, chief of the Chilean military forces, for the purpose of observing, as a representative of the American Navy, the military and naval operations then going on between the Governments of Chile and Peru and making a report thereon to the proper authorities of the Government of the United States.

now on file in the office of the Third Auditor of the Treasury be referred to the Court of Claims with the right of appeal to either party to the Supreme Court for examination and the allowance of the amount of damages actually sustained by said claimant by reason of said loss, the judgment rendered by said court to be paid out of the appropriations duly made to pay judgments rendered by said court: *Provided*, That the said damages shall only include the actual value of said canal barge at the time she sustained the injuries aforesaid: *And provided further*, That said Court shall find whether or not said injuries to said barge resulted from any fault or negligence of the owner of said barge or of his employees, and that said Court, before determining the question of damages, shall determine the question of liability of the Government,
