**CHAP. 116.**—An Act Granting an increase of pension to Lizzie Waltz.Lizzie Waltz.  
Pension increased.

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,* That the Secretary of the Interior be, and he is hereby, authorized and directed to place upon the pension roll the name of Lizzie Waltz, who was wounded on the first day of the battle of Gettysburg during a skirmish at Hanover, Pennsylvania, while giving food and administering to the wants of the Union soldiers, and who is now without means of support and physically incapacitated for any manual labor as a result of such wound, and pay her a pension at the rate of twenty-four dollars per month in lieu of the pension which she now receives as widow of Levi Waltz, a private in Company D, First Battalion, Nineteenth Regiment United States Infantry, under certificate numbered three hundred and fifty-one thousand three hundred and thirty-eight.

**CHAP. 117.**—An Act Granting an increase of pension to Thomas S. Tefft.Thomas S. Tefft.  
Pension increased.

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,* That the Secretary of the Interior be, and he is hereby, authorized and directed to place on the pension roll, subject to the provisions and limitations of the pension laws, the name of Thomas S. Tefft, late of the First Regiment New York Dragoons, and to pay him a pension at the rate of twenty-five dollars per month in lieu of the pension he now receives.

**CHAP. 118.**—An Act Granting an increase of pension to Jordan Thomas.Jordan Thomas.  
Pension increased.

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,* That the Secretary of the Interior be, and he is hereby, authorized and directed to place on the pension roll the name of Jordan Thomas, late of Company H, Third Regiment of Kentucky Volunteer Infantry, in the war with Mexico, and pay him a pension at the rate of eighteen dollars per month in lieu of that he is now receiving.

**CHAP. 119.**—An Act Granting an increase of pension to Justin O. Hottenstein.Justin O. Hottenstein.  
Pension increased.

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,* That the Secretary of the Interior be, and he is hereby, authorized and directed to place on the pension roll, subject to the provisions and limitations of the pension laws, the name of Justin O. Hottenstein, late of Company G, Twentieth Illinois Infantry, and pay him a pension at the rate of thirty dollars per month in lieu of that he is now receiving.

**CHAP. 124.**—An Act For the benefit of J. C. Rudd.J. C. Rudd.  
Payment to.

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,* That the Secretary of the Treasury be, and he is hereby, authorized and directed to pay James C. Rudd, of Owensboro, Kentucky, the sum of six hundred dollars, out

of any money in the Treasury not otherwise appropriated, being the amount due said Rudd for the rent of a post-office building in the city of Owensboro, Kentucky.

**CHAP. 125.**—An Act For the relief of Samuel D. Hubbard.

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of War be, and he is hereby, authorized and directed to amend the record of the War Department in the case of Samuel D. Hubbard, late captain of Company F, Twenty-seventh Regiment of Wisconsin Volunteer Infantry, so as to grant him an honorable discharge: Provided, That no pay or allowances shall become due or payable by reason of the passage of this Act.*

**CHAP. 126.**—An Act To remove the charge of desertion from the military record of Daniel Straw, late private, Company F, Twenty-sixth Massachusetts Volunteers.

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of War be, and he is hereby, authorized and directed to amend the military record of Daniel Straw, late private of Company F, Twenty-sixth Massachusetts Volunteers, so as to remove the charge of desertion and grant him an honorable discharge: Provided, That no pay, bounty, or other emoluments shall become due or payable by virtue of the passage of this Act.*

**CHAP. 130.**—An Act Granting a pension to Charlotte Poe.

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Interior be, and he is hereby, authorized and directed to place on the pension roll, subject to the provisions and limitations of the pension laws, the name of Charlotte Poe, widow of Isaiah Poe, a soldier in Captain William Johnson's company of Missouri troops in the war of eighteen hundred and twelve, and pay her a pension at the rate of twelve dollars per month.*

**CHAP. 131.**—An Act Granting a pension to Henry Farmer.

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Interior be, and he is hereby, authorized and directed to place on the pension roll, subject to the provisions and limitations of the pension laws, the name of Henry Farmer, late a private in Captain Chile's company, Second Regiment Tennessee Mounted Infantry, in Cherokee war, and pay him a pension at the rate of eight dollars per month.*
