CHAP. 638.—An Act For the relief of. B. F. Parlett, collector of internal revenue for the district of Maryland.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the proper accounting officers of the Treasury be, and they are hereby, authorized and directed to credit the account of B. F. Parlett, the Collector of internal revenue for the district of Maryland, with the sum of six thousand and seventy-seven dollars and seventy cents, the same being the net value of certain beer stamps received by the Collector from the Eigenbrot Brewing Company, Baltimore, Maryland, in exchange under the provisions of an Act of Congress approved June thirteenth, eighteen hundred and ninety-eight, and which stamps were stolen from the Custody of said Parlett in the city of Baltimore on the fifteenth day of July, eighteen hundred and ninety-eight.
